Fees

Patrons must pay in full at the time of enrollment

A cancellation fee of \$15.00 will be charged if the student drops out before the full class term is completed.

Annual membership is \$35.00 per student with a maximum of \$55.00 per family.

A supervision fee of \$5.00 for each 30 minutes will be charged for children left unattended in the lobby.

Returned checks will incur a \$25.00 fee payable before child can attend next class.

One free transfer is allowed per session, Additional transfers will incur a \$5 charge each. Effective 11/1/2007

Discounts

Families enrolling more than one student will receive a 10% discount on the smaller tuition.

See the front desk for second class discounts.

Policies

Parents are always welcome to view classes but must not distract the students. Parents are **not** allowed in the gym area while viewing classes. You must watch from the designated viewing area where the bleachers are located.

Students are allowed two make-ups per session. Absences may be made up during drop in times, scheduled make up days, or at open gym by appointment only. Missed classes must be made up in the session the absence occurs. Make-ups scheduled and not attended or canceled without notice are forfeited.

Classes canceled by MILLS USA will entitle patrons to an additional make up class.

Children are never to be left unattended in the lobby, viewing area or outside and must be closely supervised by the parent. We cannot be responsible for unsupervised children.

Class schedule and staff assignments are subject to change.

All scheduled classes must meet minimum enrollment to be conducted.

For the safety of everyone, all students must follow MILLS USA directions, rules, and staff instructions.

No standing or parking in the driving lane, including by the entrance, do not drive around anyone stopped to let out children

No flash photography or video lights allowed. Picture taking or video taping is allowed with permission.

Children enrolled at Mills USA are subject to having their picture taken for the purpose of Mills USA public relations and advertising. No remuneration or payment of any kind can be issued for such use. You must inform us in writing if you wish not to have your child's picture used. See office for details.
